The Cannon Beach Gallery's program of curated exhibitions enables local artists to flourish, by selling their work and placing it within a regional context. The 2015 program was supported by grants from the City of Cannon Beach and the James F. & Marion L. Miller Foundation, by our sponsors, and members.

Summer Art Camp



In 2015, the Cannon Beach Arts Association Summer Art Camp completed its 13th year of providing quality art instruction for children and adults in a safe, fun environment. Enrollment for 2015 was 87 students among 12 class topics which included watercolor techniques, jewelry design, book making, pastels, encaustic technique, printmaking, and cyanotype photographic printing. Funding for the camp was made possible via tuition costs and support from the Meyer Memorial Trust, the City of Cannon Beach Parks and Services Commission, and Martin Hospitality. Meyer Memorial Trust (MMT) funds supported the camp in 2014 and 2015 and made it possible to award scholarships valued at over \$1800 to 17 local participants over the two years. Support from the MMT enabled production of a Spanish language camp brochure and an increase to the teaching stipend provided for teachers. A paid camp director position was created in 2014 to coordinate camp logistics. The camp is held in July at the Cannon Beach Community Church.

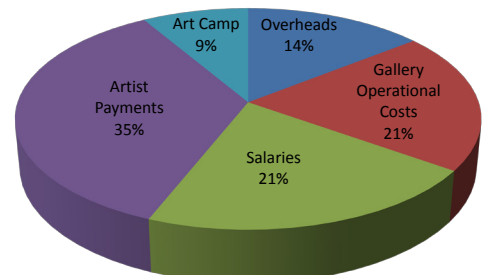

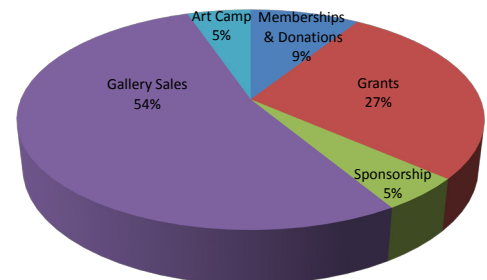
Financial Report

The Cannon Beach Arts Association's financial year runs October through September. Its 2014/2015 operational budget was \$140,668, funded through gallery sales, memberships, donations, foundation grants and funding from the City of Cannon Beach. The association ended its year with a small operational surplus enabling it to deposit \$2500 in to its Endowment, helping to secure future programs. This fund was established in 2006 through the generosity of our members and supporters. The endowment has historically been used as a reserve fund, available for use by the organization during times of financial hardship. We are working to grow our endowment so that returns may be used to support program costs.
